Legacy of One Implementation

Branches can experience a gradual decline in total membership (more membership loss than gain). Some SIR members may think that their Branch is healthy due to viewing the induction of new members at most luncheons. These healthy thoughts should take into consideration the loss of membership due to resignations – move, illness, expiration, interest, etc. All Branches should look for ways to sustain and grow their membership levels. Use the Legacy of One.

The Legacy of One encourages each member to bring a guest (friend, neighbor, new contact, etc.) with the eventual goal of the individual's membership in a SIR branch. (See attached sample)

The Legacy of One should be an integral component of the new member orientation in Branches that are sustaining their membership. Branches who have 6month new member round tables may choose to integrate the Legacy of One at this time.

The Legacy of One can also be extended to the whole membership in Branches that wish to grow.

When any member sponsors his first new member, the Big Sir may send a quarterly list of member's name and address to the State Chair of Membership and Growth for a congratulatory letter meeting the LEGACY OF ONE objectives.
